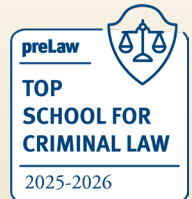

MASTER OF LAW AND LETTERS (LL.M) PROGRAM OVERVIEW

ADMISSIONS REQUIREMENTS

- ✓ Apply through LSAC, selecting LL.M program
- ✓ You must have a law degree or its equivalent from the country in which you are qualified to practice law
- ✓ Prove your English language proficiency with a minimum TOEFL iBT of 90, IELTS of 6.5, or Duolingo of 120 (not required if your native language is English)
- ✓ Submit your transcripts via LSAC's Credential Assembly Service (CAS). A minimum GPA of 3.2 is required/recommended
- ✓ Submit two letters of recommendation
- ✓ Submit a personal statement
- ✓ Submit your résumé or curriculum vitae
- ✓ Eligible, qualified applicants will be invited to interview via video conference. This is an important part of the evaluation process and is required for admission

If LL.M students meet all of the requirements set by the California State Bar, the LL.M degree will position them to be able to sit for the California Bar Exam. Students may be eligible to take the bar exam in other states. Students are responsible for determining eligibility and requirements for any other jurisdiction.

To begin the process, please create an LSAC LL.M CAS account. Creating an account requires one-time fees charged by LSAC. To help offset these costs, Western State does not charge an application fee for our LL.M Program.
