- **Regulatory Compliance:** Explore the complexities of regulatory compliance and develop skills to ensure adherence to legal and ethical standards.

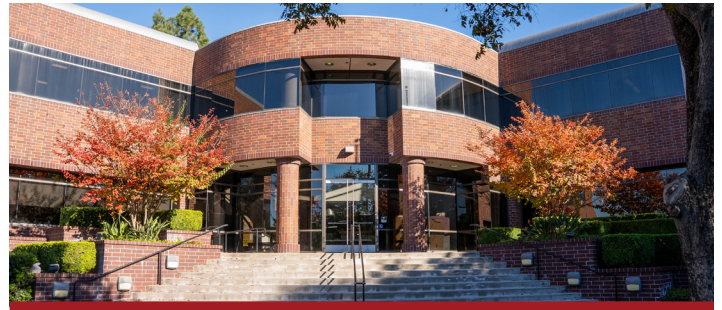

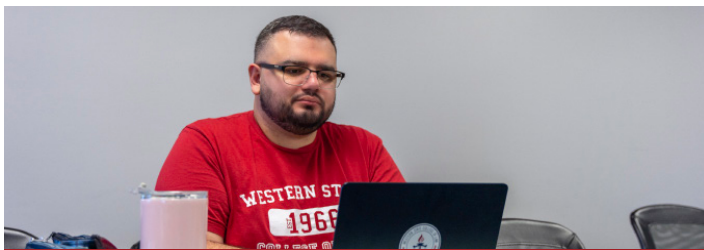

How to Apply?

Applications are accepted electronically through the Western State Master of Legal Studies application portal.

What to submit:

Prospective students must have a bachelor's degree completed prior to enrollment and submit both a program application and a personal statement detailing their goals and interest in the program.

- **Personal Statement:** A student's personal statement should be focused and a reflection of who they are. This often includes not only an applicant's motivators (accomplishments, skills, experiences, or personal motivators) but also career goals, outside interests, and anything else they believe relevant to their success within the program and who they are as an individual. The statement should also be double-spaced and no longer than 5 pages in length.
- **Transcripts:** To streamline applications, we accept unofficial transcripts for initial evaluation. Should you be admitted, official transcripts will be required prior to enrollment.
- **Letter(s) of Recommendation:** One letter of recommendation is required, additional letters may be requested in certain circumstances.
- **GRE/LSAT Scores:** While GRE or LSAT scores are optional, they may be submitted to strengthen an application.
- **Addenda:** As requested.

Please note that successful completion of this degree program will not prepare students to practice law, will not satisfy requirements for licensure to practice law, and will not provide the possibility of advance standing in a JD program, should a student in the MLS program later decide to apply for admission to a JD program.
