### MESSAGE FROM THE DEAN



The Holiday Season is many things to many people. For most of us, it seems a fitting time to evaluate where we've been and where we're going. We often hear charitable acts framed as "giving back." Professor Cheyanna Jaffke, who energized this campus community to create hundreds of gift boxes for impoverished children overseas, is another.

The end of 2012 presents us with an opportunity to reflect on the legal profession, which has so vigorously exhorted its members to be public citizens, and on the profession of legal education which has been blessed with students receptive to that message and eager to assume the responsibility of that mission.

I am grateful to be associated with this generous community of faculty, staff, students and alumni. Thank you for your generosity of spirit. Best wishes to you and your family throughout this holiday season and next year.

## Judge Firmat Swears In Bar Candidates at the Old Orange County Courthouse



Judge Francisco Firmat of the Superior Court of Orange County administered the attorney's oath to Western State's successful bar candidates on December 5th, 2012, at the historic Old Courthouse in Santa Ana. Judge Firmat, a Western State alumnus from the class of 1976, will be retiring from the bench next year, and his presence at Western State, both as a professor of trial practice and as the judge who has sworn-in hundreds of Western State graduates, has shaped the 2012 bar group -- and so many others that preceded them.

Before a capacity audience of over one hundred guests, Judge Firmat complemented the Bar Admittees on their hard work, and the good fortune that brought them to this moment. He also cautioned them on the law's seductions and cautioned them to lead balanced lives.

## Poe Appreciates Diversity Scholarship

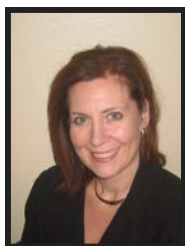

### What does being a Western State Alum mean to you?

Well, I interviewed with an Orange County firm, whose partner was a Western State alum. She saw that I was also a Western State alum and that I had participated in the Western State Legal Clinic. She hired me right out of law school. During my time with my first firm, I was involved in a large family law case, involving various business issues. Counsel for my client's corporation was a business/corporate litigation firm. While engaged in a 23 day trial with corporate counsel, I was offered an opportunity to work at the corporate firm, Enterprise Counsel Group. Now, in addition to family law, I practice business, corporate and employment law litigation. It all started with the education and opportunity afforded me by Western State.

Being a Western State Alum means being a part of a amazing group, including fantastic judges and great attorneys in Orange County that have come from Western State. I enjoy having the opportunity to share my experiences with Western State judges and attorneys in our legal community. I'm also still in touch with many of my law school alums we get together from time to time to share our mutual successes.

### Of what success are you most proud?

While at my first associate position at Hughes & Sullivan, I received both the Rising Star Award and Outstanding Leadership Award. The Rising Star award was given to a newer associate, usually less than two years at the firm in recognition of their work product, work ethic, and client satisfaction. The executive committee, including the partners of the firm, gave me the award. My second year I was a managing attorney, supervising newer associates at the same firm, and the executive committee awarded me the Outstanding Leadership Award.

### What is your first memory of Western State?

Before I even started law school, there was a meet and greet at a local law firm. We met current students, alumni and faculty—everyone from Western State was so friendly and supportive.

### What is your favorite?

My favorite memory of my time at Western State is hanging out in the student lounge on the first floor. They had redecorated and painted the student lounge. It was a good place to study and interact with other students and friends. I even recall a time when a group of us spent days practicing our presentation for Professor Brower's Gender and Law class. I'm still very good friends with one of them, Ilina who is now doing human rights law in Bangladesh. We even collaborated on an issue of international Forum Non-convenience—ha ha, Professor Koppel would be so proud!

### Prof. Mark E. Edwards, Esq.

#### What do you see as the most important/pressing issue in the legal system right now?

In the criminal system, it's a horrible waste of resources on victimless crimes and drug addiction. In the civil system, it's a lack of access to justice due to court closures as a result of budget constraints, fostered by the government's unaccountable expectations of the pension and benefits systems.

Unfortunately, everything in the practice of law is about money. That may be a cold statement, but it is true! That doesn't mean that it can't be about truth, justice and fairness; but without money, the engine of justice simply cannot run.

#### Of what success are you most proud?

I am most proud of the fact that I was able to succeed as a trial lawyer as well as a businessman in the practice of law. The business of practicing law can be extremely complicated, and even 'cut-throat,' but if you have a good head for business and managing money, you can do well as a lawyer. The problem is, once you stop, the money stops. So you need to plan for the future, as I did by putting aside money every year for retirement.

#### What do you like most about the practice of law?

Helping people—always, above any other reason—helping people. Even after almost 35 years of practice I'm still flattered when someone comes to me and asks me to help them solve a problem they can't solve. I adopted the philosophy early on that lawyers should be 'problem solvers' not 'problem makers.' I just wish more of today's lawyers would adopt that philosophy.

#### How do you view Western State's position in the legal community?

Well, I have had the opportunity to teach at different law schools. I am now a faculty adjunct at Western State. I find that the students at Western State are head and shoulders above what I expected, both academically and professionally. I'm proud of that.

#### What is your favorite memory of Western State as a student?

Gee, that's going to take a minute . . .

At the time, I just was busy working and studying. In hindsight, staying connected with many of my classmates like Jim Heiting and Henry Nelson. Many of the professional relationships I have today started with fellow students between 1971 and 1975 at Western State.

My next favorite memory is that I passed the Bar before I walked. It was the coolest thing since I finished in December of 1975; took the bar exam in February of 1976, found out I passed in May of 1976, and went through graduation in June 1976. It was a great feeling to know I had already passed while the others were just dreading the bar exam. I went right from graduation on Sunday to start my first job on Monday morning. So that was pretty cool.

### Western State Hosts D.A.C.A. Clinic

On November 10th, Western State was the site for the Deferred Action for Childhood Arrivals (DACA) clinic. The DACA clinic provided legal consultations by attorneys and trained student volunteers for members of the immigrant community eligible for temporary relief from deportation. The program grants a two-year permit, pursuant to the Obama Administration's recent immigration policy intended to benefit certain young people who came to the country as children and have attended or are currently enrolled in school. The policy, announced in June, grants immigrants here illegally work permits and temporary legal status if they can establish that they came to the United States before age 16, have lived here for at least five years, are in school or have graduated from high school and meet other requirements.



The clinic provided assistance to more than eighty individuals and was part of a collaboration by Orange County Dream Team and Western State, along with UCI School of Law, the Public Law Center, Asian Pacific American Legal Center, and the American Civil Liberties Union of Southern California. The project fulfilled Professor Jennifer Koh's vision of Western State's Immigration Clinic as an activist, collaborative, community-centered clinic. Student volunteers included Chris Cabanilla, Chrissie Padilla-Le, Christine Kim, Rosie Pondeva, Vera Marshall, Iris Franco, Nanette Munoz, Edgar Cruz, Farid Kazemi, Raul Saldana, Kristalyn Bautista, along with Immigration Clinic staff Gabriela Nieves, Oscar Lee, and Jason Wu. Earlier this fall, Western State clinic alumni Jessica Cha and Lev Zartarian, and current students Marlen Manzo and Joseil Moreira, volunteered at OC Dream Team clinics throughout Orange County.

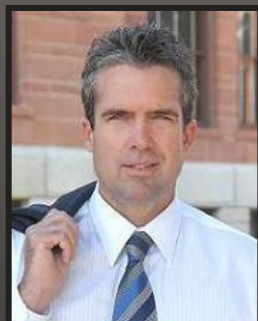

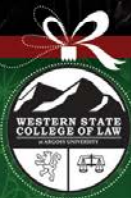

**How has the practice changed since you first started?**

It's taking cases longer to resolve—longer for plaintiffs to wait for closure. All the Boards I sit on are dealing with this Budget/access to justice issue. What it comes down to is that the Judiciary is not being treated like an equal branch of the government. You actually hear a lot of rhetoric in support of this disturbing trend from who I call, "tort *de*formists."

**How do you view Western State's position in the legal community?**

You know what? I've always placed Western State in high regard in the legal community. I wanted to go to law school in the community where I was going to practice. I was convinced by the number of judicial officers. I always been pleased with my alma mater and with my professors—whom I still know. I've always been pleased, and I'm proud of it.

**What does being a Western State Alum mean to you?**

Soon after graduating, in my time at the DA's office, I found out that Western State had given me what I needed to be better than some of the young Ivy League-trained lawyers there. The Military trained me in perseverance. But that first summer, I gained a lot of confidence in the education I'd received at Western State.
