Some tips on buying textbooks:

- The edition listed on the booklist <u>is the version</u> your professor will be using for class and required readings
- Consider purchasing <u>recommended</u> books after attending your first class; your professor may provide additional information helping you decided whether to purchase or not
- Please use the ISBN listed for confirmation of the textbook. It is the one posted on the publisher's website and is an "ISBN-13" system. However, never order a book based on the ISBN alone. Make sure that at least the title and edition/year match.
- Until you are absolutely sure you have the correct book, or you're definitely going to take the class, don't mark-up the book at all, as you might not be able to return it otherwise.
- FYI ... Books may come in varying formats not only hardbound, but ebook, kindle, paperback, loose-leaf versions, used, or rentals. Often these options are cheaper. Unless specified in the Booklist, these alternative formats are acceptable to purchase.
- ORDER EARLY! Remember, it's not just Western State starting classes in January, it is also the 200 other law schools across the country! If books come directly from the publisher, they could take up to 3 weeks to arrive.
- Consider renting books. You really don't need them after the semester is finished. The Library does have copies of all the required and recommended books on the Booklist in its Reserve Collection. However, generally only 1 book is purchased per class and are available for a 3-hour checkout, on a first-come, first-served basis.
