Some tips on buying textbooks:

- The edition listed on the booklist **is the version** your professor will be using for class and the required readings.
- Consider purchasing <u>recommended</u> books after attending your first class; your professor may provide additional information. <u>Some</u> supplemental titles may be available through the library or Lexis Digital Library.
- Please use the ISBN which is the one posted on the publisher's website for the hardcover book. <u>Never order a book based on the ISBN alone</u>. Make sure that at least the <u>title and</u> <u>edition/year match</u>. Note: listed ISBN may be the ISBN for hard copy in addition to other resources (case book, ebook, or other material)
- Until you are absolutely sure you have the correct book, or you're definitely going to take the class, don't mark-up the book at all, as you might not be able to return it otherwise.
- FYI ... Books may come in varying formats not only hardbound, but ebook, kindle, paperback, loose-leaf versions, used, or rentals. Often these options are cheaper. Unless specified in the Booklist, these alternative formats are acceptable to purchase.
- ORDER EARLY! Remember, it's not just Western State starting classes in January, it is also the 200 other law schools across the country! If books come directly from the publisher, they could take up to 3 weeks to arrive.
- Consider renting books. You really don't need them after the semester is finished. The Library does have copies of all the required and recommended books on the Booklist in its Reserve Collection. However, generally only 1 book is purchased per class and are available for a 3-hour checkout, on a first-come, first-served basis.
