**Some tips on buying textbooks:**

- Please use the ISBN listed for confirmation of the textbook. However, never order a book based on the ISBN alone – make sure at least the title and edition/year match.
- Until you are absolutely sure you have the correct book, don't mark it up, as you might not be able to return otherwise.
- FYI ... Books may come in varying formats – not only hardbound, but eBooks and loose-leaf versions. Often these are cheaper. Unless specified in the list, these alternative formats are acceptable to purchase. Carolina Academic Press (CAP) and LexisNexis are the two major publishers who most often offer alternative versions.
- ORDER EARLY! If books come directly from publisher, the book could take up to 3 weeks to arrive.
- The Library does have copies of all the required textbooks, however only 1 copy of the book is bought per class. Library textbooks are available to use on a first-come, first-served basis, so try to buy your own personal copy of a textbook when possible.

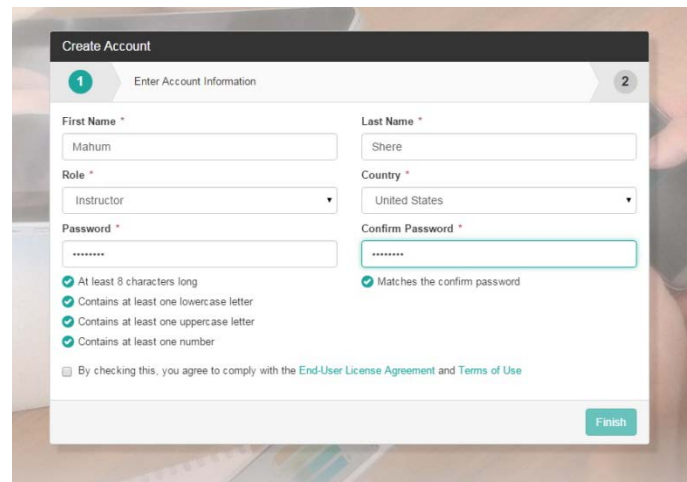
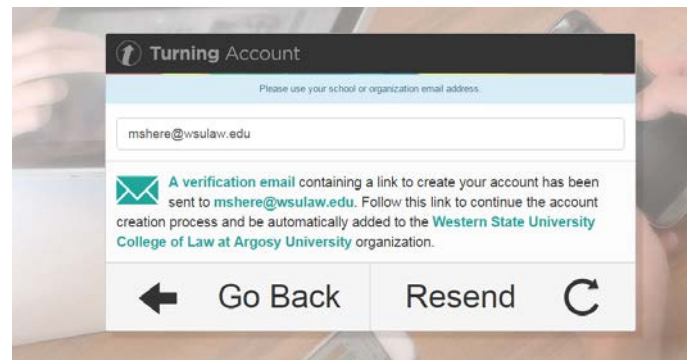
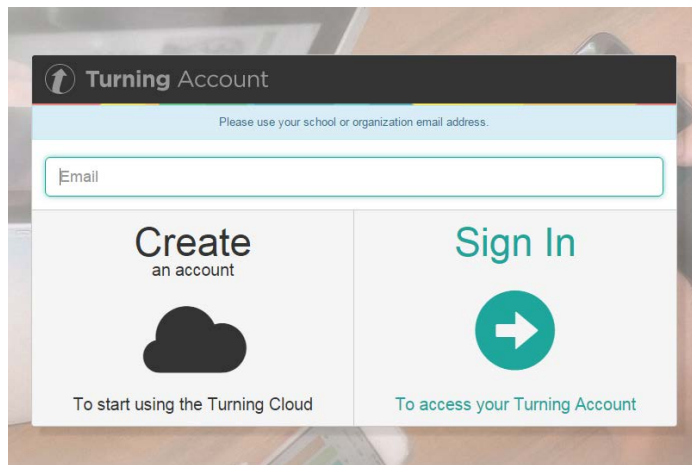
## “Clicker” Information for Evidence Class
