**Some tips on buying textbooks:**

- Please use the ISBN listed for confirmation of the textbook. However, never order a book based on the ISBN alone. Make sure that at least the title and edition/year match.
- Until you are absolutely sure you have the correct book, or you're definitely going to take the class, don't mark-up the book at all, as you might not be able to return it otherwise.
- FYI ... Books may come in varying formats – not only hardbound, but ebook, kindle, and loose-leaf versions. Often these are cheaper. Unless specified in the Booklist, these alternative formats are acceptable to purchase.
  - Note: that if you do purchase an alternative version, the format listed on the Booklist is the one the professor will be using when referring to page numbers and required reading.
- ORDER EARLY! Remember, it's not just Western State starting classes in August, it is also the 200 other law schools across the country! If books come directly from the publisher, they could take up to 3 weeks to arrive.
- Consider renting books. You really don't need them after the semester is finished.
- The Library does have copies of all the required and recommended books on the Booklist in its Reserve Collection. However, generally only 1 book is purchased per class and are available for a 3-hour checkout, on a first-come, first-served basis.

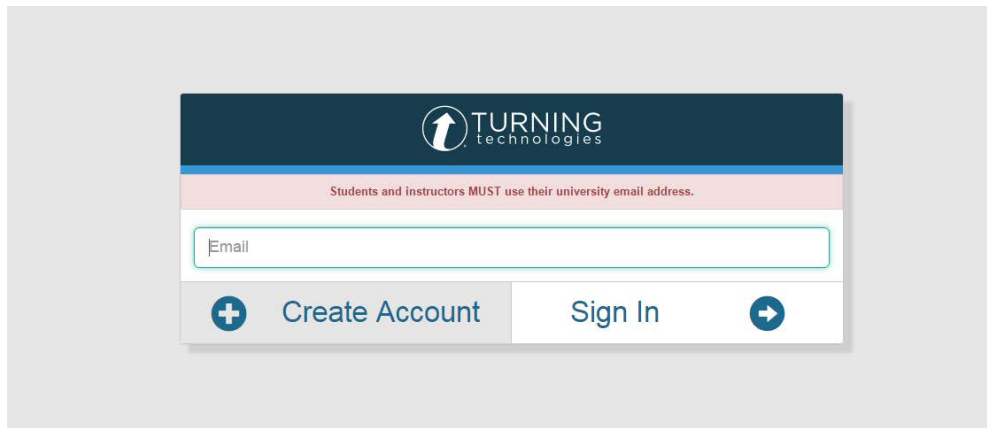
## “Clicker” Information for Molko’s Evidence Class

Both the QT device and Responseware software should be purchased directly from the company website at <http://store.turningtechnologies.com>

**Step 1:** Once on the website, create an account using your student email account.

- It’s important that you use your student email account because all the offering / pricing information is tied to an affiliation with the school.
- When working through all the steps of creating an account, please SKIP anything that tries to tie your account to our Learning Management System (Blackboard).



**Step 2:** Once you receive your device. You need to log back in to your Turning Technologies account and register the device.

- Your clicker should look something like the one pictured.
